
# **Helmet Pad Suspension System**







#### Requirement

MARADMIN 480/06 states that the pad suspension system is the only authorized suspension system to be used in the LWH. Further, only the pad suspension system purchased by the Consolidated Issue Facility or the supply system is authorized for use in the LWH.

#### Overview

The pad suspension system consists of 7 pads that are attached to the helmet using hook disks. The pads are composed of two foam layers covered with a synthetic loop composite fabric on the side that attaches to the LWH, and a knit material on the side that rests on the Marine head.

The pads can be arranged in the configurations shown above. A minimum of 5 pads must be worn.

A Marine has the option of using two different sizes of pads. There is a size 6 (% inch pad) and a size 8 (1 inch pad). They can be used in any combination in order to provide proper fit.

Independent testing demonstrated that both the sling suspension system and pad suspension system provide equal protection from ballistic blunt trauma (e.g. fragmentation, shrapnel, or bullet). However, the pad system demonstrated better performance than the sling suspension system in providing protection from non-ballistic blunt trauma (e.g. blunt force, bump from falling, or falling debris).

Research is being conducted to find a means to provide protection against blast (e.g. overpressure or percussion from explosives).
