I. CAMP STONEMAN, CALIFORNIA.—1. *Effective 1 July 1954*, a Personnel Center is established as a class I activity at Fort Ord, California, a class I installation under the jurisdiction of the Commanding General, Sixth Army.

2. *Effective 1 July 1954*, the Reassignment Station and Transfer Station, located at Camp Stoneman, California, are transferred to and designated activities of the Personnel Center at Fort Ord, California.

3. *Effective 1 August 1954*, a Personnel Center is established as a class I activity, under the jurisdiction of the Commanding General, Sixth Army, at Oakland Army Base, California, a class II subinstallation under the jurisdiction of the Chief of Transportation.

4. *Effective 1 August 1954*, the Oversea Replacement Station and the Oversea Returnee Station, located at Camp Stoneman, California, are transferred to and designated activities of the Personnel Center at Oakland Army Base, California.

5. *Effective 31 August 1954*, Camp Stoneman, California, a class I installation under the jurisdiction of the Commanding General, Sixth Army, is placed in an inactive status.

II. QUARTERMASTER ACTIVITIES.—*Effective 1 July 1954*, the quartermaster class II activities located at 111 E. 16th Street, New York, New York, are discontinued and their missions and functions are transferred as follows:

1. The New York Quartermaster Purchasing Agency is transferred to and merged with the Philadelphia Quartermaster Depot, Philadelphia, Pennsylvania.

2. Headquarters, Quartermaster Inspection Service Command, is transferred to Philadelphia, Pennsylvania, and reestablished as a quartermaster class II activity under the jurisdiction of The Quartermaster General, and located at the Philadelphia Quartermaster Depot.

3. The New York Quartermaster Inspection Service Field Office is transferred to Philadelphia, Pennsylvania, and redesignated the Eastern Regional Inspection Office, and assigned as an integral organizational element of Headquarters, Quartermaster Inspection Service Command, at the Philadelphia Quartermaster Depot.

4. The Commercial Warehouse Field Office is transferred to Philadelphia, Pennsylvania, and is reestablished as a quartermaster class II activity under the jurisdiction of The Quartermaster General, and located at the Philadelphia Quartermaster Depot.

III. UNITS ENTITLED TO BATTLE CREDITS.—1. Central Pacific.—Section V, WD General Orders 85, 1945, as amended by paragraph 4, section I, DA General Orders 72, 1948, pertaining to the Central Pacific campaign, is further amended as follows:

Delete: 152d Engineer Combat Battalion.

2. Ryukyus.—Section XIX, WD General Orders 12, 1946, as amended by paragraph 20, section I, DA General Orders 72, 1948; paragraph 13, section II, DA General Orders 6, 1950; paragraph 16, section I, DA General Orders 37, 1950; and paragraph 19, section III, DA General Orders 32, 1953, pertaining to the Ryukyus campaign, is further amended as follows:

Delete: 51st Provisional Military Police Battalion.

Add: 51st Military Police Battalion.

IV. UNITS CREDITED WITH ASSAULT LANDINGS.—Ryukyus.—Paragraph 7, section II, WD General Orders 109, 1946, as amended by paragraph 2, section II, DA General Orders 23, 1947; paragraph 6, section III, DA General Orders 6, 1950; and section II, paragraph 8, DA General Orders 37, 1950, pertaining to the Ryukyus assault landings, is further amended as follows:

h. Okinawa.

Add: Company C, 1st Provisional Military Police Battalion.
