### AMAL 653, Corpsman Assault Pack (CAP)



#### REQUIREMENT

- Statement of Need dated 29 September 2006 with modification dated 04 December 2006.

#### OVERVIEW

- The Corpsman Assault Pack (CAP) is the culmination of an ongoing modernization and product improvement process that began with an UUNS that identified the need to find a replacement for the legacy Unit One Medical Kit carried by Hospital Corpsmen since WWII. The product transformed into the MOLLE Medical Bag in the mid - late 90's, and with the Marine Corps requirement to change from MOLLE to ILBE, was adapted and established as an AMAL in December 2006.
- AMAL 653 is designed to be mission-tasked with a variety of COTS trauma casualty care products for emergent health care delivery in the combat environment.

#### FEATURES

- Improved design accomplished by adding an empty individual thigh rig assembly and Combat Lifesaver Bag, which allows for individual outfitting based on the daily mission, lightens the load, and improves ergonomics.
- Expedited sustainment through established BAS AMAL 635/636.
