

In addition, offerors shall separately provide three (3) Rifleman variant pouch kits, three (3) Grenadier variant pouch kits, three (3) SAW Gunner variant pouch kits, and three (3) Pistol Bearer pouch kits. \*\*Offerors shall provide instructions for assembly and optimal configuration of each variant pouch kit on the base system vest\*\*.
